HOW DOES IT WORK?

- › According to the US regulation, sender and recipient must be the **same person**. Import duties and taxes apply.

WHAT CAN I SEND?

- › Now you can send wine up to 18% ABV as stated in the shown matrix.

WHAT DO I NEED?

- › The **DHL ServicePoint** staff will provide you with all the required paperworks.
- › For shipment value **over 150 €** the Economic Operator Registration and Identification number is required. You can request a temporary **EORI** number at any **Italian Customs Office**.
